CUSTOMS : ECS – Export Control System phase II implementation postponed till 01/09/2009

Belgian Customs and Excise have announced earlier this week that the implementation of the ECS phase II will be exceptionally postponed till 01/09/2009. The system should have started on 1/07/2009.

ASIA – EUROPE : capacity further reduced

While carriers are further reducing capacity a General Rate Increase (GRI) has been announced to be implemented on 01/07/2009.
